De . Mrs. Sinclair:

On behalf of the Medical Sub-Committee, I wish to thank you for the invitation ended to the Committee to participate in the discussions of the Programme aittee on the terms of reference of the Medical Sub-Committee. At its meeting the March 1950 the Medical Sub-Committee recommended a revision of its terms of reference, of which I understand you have been informed, and which I believe all meet the views of all concerned. I understand that some question has a raised informally as to the meaning of the phrase relating to questions which the referred to the Medical Sub-Committee by "other organs of UNICEF". The intention of this phrase was to state the fact that the Programme Committee or Executive Board might, on some matter not now foreseen, wish the advice of Medical Sub-Committee. If such an event does not occur, this clause will be retained. If such a request for advice by the Programme Committee or Executive adappears desirable at any time, the terms of reference of the Medical Sub-Committee will then not again become an issue.

I hope that the foregoing explanation will clarify the meaning of the Sub-Comittee's recommendation and that the Programme Committee will be in a position to act without the necessity and expense of attendance, at the meeting of the Programme Committee on June 5.
