I am pleased to announce the following appointments:

1. Ms. Karin E. Lokhaug as Deputy Executive Director (Operations):

Ms. Karin E. Lokhaug, a national of Norway, was born in December 1943. She studied in Norway and obtained her Intermediate University Degree in Bank Economics (1971) at the Norwegian College of Banking.

Ms. Lokhaug joined UNICEF in September 1985 as Comptroller of the then Comptroller's Division which is now the Division of Financial Management (DFM).

Prior to Ms. Lokhaug's appointment with UNICEF, she was with the Christiania Bank of Oslo serving in various capacities from 1962 until she joined the bank's leadership programme in 1969. After serving as Secretary to the Board of Directors and, later, as Manager at Bergen Bank, she rejoined Christiania Bank (Baerum) and served successively as Assistant General Manager, Deputy General Manager and, from 1982 to August 1985 as General Manager (Marketing Division).

Ms. Lokhaug will assume her new functions as Deputy Executive Director (Operations) on 15 December 1987.

Mr. Karl-Eric Knutsson remains on leave of absence to May 1988, following which he will assume a senior field post within UNICEF.
