RE: Proposed Schedule and Programme for the World Summit

Enclosed is the revised Schedule and Programme for the World Summit resulting from last Friday's Working Group on Format and subsequent consultations among the Initiators. This draft is being circulated to the Initiators for their confirmation by Monday morning, but it has already been endorsed (with his edits) by Ambassador Fortier. It will be sent to the full Planning Committee for its consideration on 27 June, but stands a good chance of emerging largely in-tack. I would plan to share these papers with our United Nations counterparts <u>after</u> they have been cleared by the Initiators on Monday.

Please review these papers carefully for their apparent implications - and questions - upon your areas of responsibility. (Please particularly note such adjustments as the fact that the Saturday evening dinner is now proposed as exclusive to Heads of State/Government, rather than 6 times that number.)

At our Monday meeting, we will need to go through item-by-item, with a view toward:

- -- identifying that which can be considered as "firm" information, pending confirmation by the full Planning Committee on 27 June, and could be reflected in the 1st Aide Memoire, which we are instructed to issue next week;
- -- that which raises questions which <u>we</u> need to provide option answers for [eg, possibilities for interpretation facilities around the dinner/luncheon table(s)] for consideration by the Initiators and Planning Committee;
- -- that which remains as questions for the Initiators/Planning Committee, but for which we should prepare specific recommendations.

We have 106 days to go.
