Emergency Programme Status

Sudan, September, 1994

1. General Situation

- The fourth round of the IGADD sponsored peace negotiations between the Government of Sudan, SPLA (mainstream) and SPLA (United) were convened in Nairobi on 7 September. On 8 September the talks were adjourned indefinitely because of the differences between the parties to the conflict on two main issues. These are self-determination for southern Sudan and the relationship between the state and religion. While the SPLA factions demanded that negotiations should include the two subjects, the Sudan delegation stated that they were not prepared to negotiate a secular constitution for the Sudan or the self-determination option which would involve separation for southern Sudan. Sudan Government had announced that its delegation to the talks will be headed by the Political Advisor at the Presidency, Ghazi Salah el Din, instead of the Speaker of the Transitional National Assembly, Mohammed El-Amin Khalifa, who led the Government delegation during the previous rounds of the peace talks.
- 1.2 President Al Bashir attended a meeting for the Heads of the five IGADD countries (Eritrea. Kenya, Uganda, Ethiopia and Sudan) on 19 September to discuss the future of the peace talks. The meeting ended without reaching any agreement.
- 1.3 During September, insecurity in several areas in southern Sudan has directly affected UN/OLS relief activities:
- 1.4 In Northern Bahr El Ghazal, several WFP staff were relocated from Akak (southwest of Mayen Abun) on 5 September, due to SPLA inter-factional fighting in the area north of Mayen Abun which began on 4 September. On 7 September, following advice from area Commanders in Northern Bahr-el Ghazal, UN/NGO staff numbers were reduced in areas surrounding Mayen Abun while OLS personnel in the towns of Akon and Lietnhom are on alert until the situation improves.
- 1.5 The staff of the Sudanese NGO, CUSH, were robbed of personal items when their vehicle was stopped by armed Turkana in Kenya near the Sudan border. Further south in Kenya, near the town of Kainuk (70 km south of Lokichogio, on the road to Lodwar) an NGO convoy was fired on by armed men, and one vehicle was slightly damaged. However, no injuries were reported in either incident.
- 1.6 An open gun battle occurred in Gulu town on 30 August between Ugandan military and armed rebels. A hotel in Gulu was burned down on the night of 4 September, reportedly by the Lord's Resistance Army.

- 1.7 OLS advised all NGOs moving through northern Uganda to cease road movement in the face of continued incidents in the last week of August in which commercial passenger and transport vehicles were attacked in the Arua, Kitgum-Gulu and Kitgum-Lira areas.
- 1.8 UNICEF established a logistics base in Kosti, 400 km south of Khartoum, which is a better position for emergency program supplies in the south and the transition zones. It also opened an office within the current WFP facilities, assigned staff and contracted overall warehouse capacities exceeding 3,600 cubic metres.
- 1.9 The Kosti base affords a more forward point from which all corridor options for the delivery of supplies into the south can be exploited: rail delivery to Bahr El Ghazal; river delivery to Upper Nile and Equatoria; road delivery to Southern Kordofan and Southern Darfur, as well as airlift options. It will also strengthen the degree of support to UNICEF's river health outreach programmes on the WFP barges. It will add to savings in transport and handling from Port Sudan.
- The annual joint needs assessment began on 29 August ex-Nairobi and on 1 October ex-Khartoum. It will cover more than 70 sites in SPLA and GOS held areas of southern Sudan and the transitional zone with the aim of identifying and forecasting humanitarian requirements for the Sudan in 1995. In SPLA-held areas participants include representatives of UN agencies, NGOs and the SPLA relief associations. Organizations operating ex-Khartoum include UN agencies, RRC, donors, national and international NGOs.
- In Khartoum, UNICEF hosted an orientation meeting for the needs assessment teams on 29 September. The UN (UNICEF, WFP, WHO, FAO, UNEU), RRC, 17 NGOs and four donors (USAID, the Netherlands Government, ODA, EU) will participate in the needs assessment which will last from the first to 20 October. The 32 locations which will be visited by this team include Malakal, Canal, Obel, Nagdiar, Dolieb, Gogrial, Aweil, Tonj, Rumbek, Wau, Yirol, Juba Town, Rokon, Liria, Yei, Ngangala, Tali Post, Terekeka, Mongalla, Gemiza, Nyala, Raja, Ed Dein, Renk, Meiram, Abyei, Bentiu, Mayom, Kosti, Kadugli, Rashad, and Khartoum.

2. Impact on Women and Children

2.1 Final results from the recent Measles/Polio campaign show that 383,856 children were immunized for measles (47%). These included 238,600 children by OLS Khartoum and the other 145,256 children by OLS Nairobi. The campaign targeted over 806,000 under fives (500,000 ex-Khartoum inclusive of 198,000 southern war-displaced in Khartoum, and over 300,000 ex-Nairobi). This represents the largest number of children immunized since the inception of OLS.

- 2.2 Among the main constraints to this effort was the timing of the immunization and its coincidence with the early rains. The disruption of the Wau train operation prevented reaching 10,000 children. Most frustrating was that the health teams working on the barge convoys were able to reach only 7% of the 100,000 accessible children in the river corridors. This was primarily due to limitations of time at each location because of the food drop off schedule as well as inadequate social mobilization in advance of barge arrivals.
- 2.3 OLS/Nairobi and seven NGOs have completed assessments of 14 sites by mid-September and plans to visit a total of 40-45 locations.
- 2.4 The disease morbidity report for the month of August from eleven peace villages in Kadugli, southern Kordofan, showed the following results:

3. Major Goals

3.1 To provide emergency relief assistance, primarily for women and children among 4.1 million displaced and war-affected populations. To provide basic social services and rehabilitation assistance to relocated populations with a special focus on the most vulnerable groups.

Programmes

Based on priority problems identified by needs assessment missions, operational capacity, access, security, and previous experiences, UNICEF is implementing an emergency programme that covers war-affected and displaced populations. Based in Khartoum and Nairobi, the programme, now into its sixth year, is implemented in cooperation with the GOS, the SPLA factions, UN agencies and various NGOs. Funding remains a major constraint in meeting needs. Assessments conducted during October/November 1993 indicated a population of about 5.2 million in need of non-food assistance. UNICEF plans to reach about 80% of this population (4.1 million) with services such as health, nutrition, water and environmental sanitation, education, household food security, and relief and shelter.

Emergency Health Services

- 3.3 The National Department of the Control of Diarrhoeal Diseases "CDD" and UNICEF have organized the National CDD week during 17 24 September, 1994, to promote and accelerate CDD activities.
- 3.4 The objectives of the week were to reduce diarrhoeal related morbidity and mortality among children <5 years of age, to increase the Oral Rehydration Therapy (ORT) rate use towards achievement of the 80% target of the mid-decade goals, and to celebrate the 25th anniversary of Oral Rehydration Salts (ORS) discovery.
- 3.5 The CDD week had a nation wide coverage with state level involvement and special emphasis on southern states and displaced communities. In Khartoum, the opening ceremony on 17 September was attended by government officials, NGOs popular organizations, and representatives of WHO and UNICEF. In their addresses to the gathering, GOS, UN, NGO representatives confirmed their commitment to the CDD and pledged to accelerate actions in this respect. A running race was organized by the Sudanese Red Crescent on the same day.
- 3.6 In the displaced camps and squatter areas around Khartoum, national and international NGOs participated in establishing ORT(Oral Rehydration Therapy) centres in which ORS (Oral Rehydration Salts) is distributed and children with diarrhoea were treated.

- These NGOs were GOAL, ADRA, Concern, SRC, SCC and Muwafag. The Federal Minister of Health had visited these centres on 19, 20 and 21 of September, 1994.
- 3.7 Eastern Equatoria held its CDD (control of diarrhoeal diseases) week with the support of Bahr el Jebel State on 17-23 September. One ORT corner was opened in Torit hospital and one in Kapoeta hospital. Each hospital received an ORT corner set and cartons of ORS.
- 3.8 The Wali (governor) of Bahr El Jebel State, accompanied by the Deputy Minister of Health, toured health facilities and addressed the public at the AICF built Muniki Health Centre in commemoration of CDD week in Juba on September 7th.
- 3.9 Immunization coverage for the month of August in Juba town is as follows:

- 3.10 UNICEF barge health teams for the "Tabaldia", bound for Juba, and the "El Mugren", have embarked on the WFP barges since September 13th. While the Juba mission is expected to last up to two months, the Lake Jur trip will take the better part of a month.
- 3.11 The barge health teams continued the implementation of UNICEF's four fold strategy: immunization against measles and polio, distribution of Vitamin A, provision of basic curative services and gathering of health information including the use of rapid nutritional assessment techniques.

- 3.12 Over 575 children and 1,500 patients were seen by UNICEF health teams while operating from the WFP barge "Biarritz" in the Tonga/Fanjak corridor. Vitamin A distribution also continued.
- 3.13 Rapid nutrition surveys have found malnutrition rates of 25-30% in most areas (MUAC). Malaria and conjunctivitis were reported as the most common diseases.
- 3.14 In Malakal, UNICEF and local NGOs organized two health education courses for 62 primary school teachers and 90 students of the Malakal College of Education. Topics in the week long course included hygiene, protection of water sources, water born diseases including guinea worm, diarrhoeal disease control, EPI and nutrition.
- 3.15 As part of the joint SCF (US)/UNICEF programme in the transitional zone of southern Kordofan.UNICEF and SCF "US" distributed 14 SCF ABC kits, 16 WB kits and 1 ctn of Benzoate to the functioning health facilities in some target villages in Southern Kordofan. This included the rural councils of El Dilling, Salara, Habila and El Kurgue, as well as three primary health care units in El Dilling town. In addition, 20 MT of CSB was transported by road from El Obeid to Kadugli and 7.5 MT CSB were airlifted by UNICEF's aircraft from Kadugli to Abeyi and Meiram.
- 3.16 The Buluk Pediatric hospital in Omdurman, which serves as a referral hospital for Omdurman's displaced persons, has received infusion sets, duodenal tubes, nasal feeding tubes, and a cannula kit. This medical equipment is for children only and is utilized for the treatment of severe malnutrition and other severe illnesses which cannot be dealt with in the displaced camps' clinics.
- 3.17 The Islamic Charitable Society for Southern States in Gezira has received medicines from UNICEF, namely twelve SCF/UK kits and six SCF/UK booster kits. This NGO mostly services Southerners in six health centres headed by medical assistants: two health centres in Gezira (Dardaka and Marinjan displaced camps) service 300 displaced families; two health centres in Sennar (Abbyay and Qalea displaced camps) service 284 displaced families; and, two health centres in Damazin (Sika Hadeed and Hay ez Zuhur displaced camps) service 537 displaced and returnee families.
- 3.18 UNICEF/ OLS (Nairobi) distributed 14,000 pieces of filter cloth in 170 endemic villages in Bahr El Ghazal where over 9,000 reported cases of emergent guinea worm have been identified, the distributions have included the Faso-Fani cloth (West African dress fabric) of which 500 metres have been provided to women groups in southern Sudan. With the logo of the guinea worm programme on it, the cloth offers an attractive means of promoting awareness while addressing the problem of unsafe water.
- 3.19 Surveillance of guinea worm cases was started in Waat and other locations in Upper Nile. The ministries of health in the three Upper Nile States prepared their plans of

- action for the interruption and eradication of guinea worm. They also selected local supervisors who will be trained as trainers.
- 3.20 The health team in Meiram displaced camp of southern Kordofan reported 21 guinea worm cases among the new arrivals to the camp. Health education and treatment activities have been intensified.
- 3.21 Billing (Lakes) and Lafon (Eastern Equatoria) were identified as new guinea worm sites. UNICEF will work with the SRRA in Billing and with both CARE and RASS in Lafon.
- 3.22 The results of the surveillance of guinea worm in northern Bahr el Ghazal are shown in the following table:

Supplementary Feeding

3.23 A total of 100 MT of supplementary food was delivered to Malakal by the WFP barge "El Canal". A second assignment of 100 MT, to be delivered soon, shall meet supplementary food needs in the Malakal/Sobat area until December.

Household Food Security

- 3.24 The Household Food Security Project ex-Khartoum (HFS) has provided a total of 402 MT of seeds to 81,315 households with an expected yield of 33,100 MT in the southern regions and Southern Kordofan as follows:
- 3.25 In Equatoria, UNICEF provided 33% of the total seed distributed, i.e. 93 MT which was distributed to 38,570 households in 26 locations.
- 3.26 In Upper Nile, UNICEF provided 99% of the total seed distributed, i.e. 148 MT which was distributed to 26,300 households in 22 locations (up from 18,600 households initially planned for);
- 3.27 In Bahr Al Ghazal, UNICEF provided 96% of total seeds distributed, i.e. 73 MT which was distributed to 7,445 households in 14 locations (up from 6,800 initially planned for);
- 3.28 In South Kordofan, UNICEF provided 83 MT of seed which was allocated to 9,000 households in 57 villages (up from 9,000 initially planned for)
- 3.29 Field monitors have conducted the HFS monitoring in various locations, working in collaboration with local authorities and specifically gauging rainfall, temperature and pests incidence. The monitoring strategy was comprised of the development of a basic information base about assisted households, monitoring of food consumption patterns and the market price of basic food items. Additionally, the advent and progress of the rainy season was monitored by a decidual reporting system. Training workshops were held in Malakal and Wau for participating NGOs.
- 3.30 Seed bulking was organized in Malakał and Wau where 200 feddans were allocated on which sorghum was cultivated. The objective was to ensure that seeds would be available for 16,200 households from each allocated area as early as the next planting season (January/February).
- Parallel to seed bulking, the project initiated a revolving seed system aimed at starting seed banks in different locations. This system is expected to collect seeds distributed at a level of 35% repayment, totalling 118 MT in its first year. Total sorghum seeds expected to be available for the 1995 planting season may reach 190 MT which would satisfy seed requirements for 40,000 households.

- 3.32 As a capacity building component of the HFS project, local blacksmiths were contracted to produce 7,700 mallodas (Sudanese hoes). The project is planning to conduct a training workshop for blacksmiths in different locations to upgrade their production and investigate the prospect for further support with the equipment needed for better production.
- 3.33 The HFS project is being coordinated with thirteen different NGOs, state agriculture and education ministries, the RRC and the local agriculture and relief committees.
- 3.34 A Khartoum based HFS officer accompanied by a US AID staff member visited Juba in September and reported a significant drop in the price of sorghum since early August. This was attributed primarily to the present sorghum bumper harvest in September.
- 3.35 Prices of a 90 kg sack of sorghum were found to have dropped from LS. 40,000 to LS.11,000 in the last month. The team also reported that the harvest of okra, groundnut, maize and tomatoes was noticed in the markets.
- 3.36 In Kapoeta, where 1,600 households have benefitted from HFS inputs and in five large villages namely Karinga, Machi, Paringa, Rewoto and Nyagi, the second harvest of sorghum may exceed the September one.
- In areas serviced by OLS southern sector, efforts are aimed to decentralize veterinary services: NGOs are being encouraged to obtain at least one full time veterinary officer on the ground. A number of NGOs have already done so, including OXFAM-UK, SCF-UK, ACROSS, ADRA, DOT and CRRS.
- 3.38 Over 60 women in Jebel Aulia displaced camp are being trained in soap-making as part of HFS project for Displaced Women. This aims to upgrade their social and economic status, create income-generation activities and educate adult women in practical skills. Literacy classes are on-going and targeting 350 women.
- 3.39 A home gardening project in Jebel Aulia is providing technical assistance to 105 women. The produce of the home gardens will be used for home consumption and for sale. Market sheds have been provided for the women who plan to sell their produce.

Water Supply, Environmental Sanitation, and Hygiene Education

3.40 In a meeting between UNICEF and the Ministry of Finance and Planning on 5 September, it was announced that the federal government has decided to allocate approximately LS. 110 million for the execution of rural water supply schemes in the southern states.

3.41 The Federal Minister of Health visited Malakal on 9 September, travelling by barge from Kosti. Accompanied by the Director of EPI and other senior FMOH officials, the Minister declared the Government's commitment to establishing and rehabilitating health facilities in Renk, Melut, Kodok, Kaka, Wadakona, Obel, Canal, Nagdiar and other river towns and villages, adding that a centre for the management and treatment of Kala Azar will be established in Upper Nile.

Displaced Movement/Relief and Shelter

3.42 The results of a house-to-house head count registration conducted by WFP/RRC/IARA/Dawa/SCC/SRC/Sudan Aid in August shows that the population in the displaced camps around Malakal has decreased (see table).

The displaced in Dolieb and Ogut are served from Obel 2 and Topagia is served from Obel 3.

- 3.43 UNICEF distributed 40 bags of CSB and 19 cartons of BP-5 to Malakal's Pediatric Hospital, Sudan Aid and IARA. 615 fishing lines and 30,000 hooks were released to Sudan Aid, IARA and SCC for distribution in Malakal and its surrounding areas.
- 3.44 A GOS/ WFP/ RRC/ UNICEF mission assessed Kajo Keji and found that about 1,500 people, the majority of whom were women, live in Kajo Keji town while about 3,000 people live in the village Kansuk 25 km north of Kajo Keji. Approximately 30 people were returning from Uganda to Kajo Keji every day. These people were in great need of food, shelter and social services.

Emergency Education/ CEDC

- 3.45 A workshop held on 17-18 August in Amman, Jordan was attended by CEDC (children in especially difficult circumstances) specialists from Sudan, Jordan, Iraq, Palestine, Kuwait, Tunisia, Lebanon and the United Arab Emirates. The production of a manual for war-traumatized children was discussed. Sudan and Iraq were chosen as pilot cases because they are countries experiencing on-going civil strife. The manual will be tested in Sudan and Iraq before the end of the year. The manual is limited to the MENA region as these countries have similar values, norms and socio-cultural backgrounds.
- 3.46 The participants were briefed on the Toto Chan Trauma Centre which UNICEF is establishing in Juba. They showed great interest in it and most agreed that it would be useful to create a coordinating body in the future so that the Toto Chan Trauma Centre can be used as a coordinating centre in the MENA region. The coordinating centre could, for example, provide research, training, capacity building, the exchange of information, and a regional/international network system.

Aircraft/Barge/Rail Operations

- 3.47 In September, the UNICEF Twin Otter has flown 111.25 hours and transported 141 passengers together with 48.6 MT of cargo.
- 4. Status of Funding (as of the end of September)
- 4.1 The total UNICEF component of the final 1994 SEPHA Appeal for the Sudan is US\$ 41.02 million, which includes an additional \$ 620,000 for Kala Azar. The allocation between Khartoum and Nairobi has been revised in accordance with NYHQ CPSS: \$ 20.59 million (50%) is proposed for relief operations from Khartoum, and US\$ 20.43 million (50%) for Nairobi operations.
- 4.2 By the end of September, receipts amounted to \$ 17.54 million, a 42.8% of the total appeal. Contributions of about \$ 644,122 from Denmark are in the pipeline.
- 4.3 About 84% of the funds received to date, some \$ 14.7 million, are earmarked for OLS Nairobi, and constitute 72% of Nairobi's estimated requirements. Khartoum receipts have increased to \$ 2.77 million, or 13.5% of Khartoum's Appeal.
